
Representative Assembly was held in June. It was more than a business meeting; it was a chance to connect with others who still want to make a difference, especially for the retired teachers of Indiana.

Legislative News by Gary Stoltz

The Indiana General Assembly started their "long session" on January 2, 2023 and ended it in the early morning hours of April 28, 2023 by passing a \$44.6B two year budget for the state of Indiana that Gov. Holcomb immediately signed into law. Sadly, this final version did not contain either a COLA or a "13th check" enhancement for retired educators for the next two years. My records indicate that this result has only happened once before since at least 1985. On a positive note, the inclusion in the budget dedicating nearly \$3B to pay down the unfunded liability in the Pre96 Teachers Retirement Fund is significant. Thank you to members who contacted their representative or Senator to support the IRTA Legislative Committee. IRTA will continue to pursue a pension enhancement in the next session.

Indiana Retired Teachers Association Foundation (IRTAF) News by Gary Stoltz

The IRTAF supports teachers who are currently teaching in our public schools. If you know a teacher who would like to do a special project in their classroom, but lacks funds for it, IRTAF can help.
